

ORDINANCE NO. 646

AN ORDINANCE RELATING TO GARBAGE FOR COLLECTION AND FOR CHARGES TO BE LEVIED FOR THE TOWN OF ODESSA, WASHINGTON, AMENDING ORDINANCE NO. 643 AND AMENDING O.M.C. CHAPTER 8.08, SECTION 8.08.240 OF THE TOWN OF ODESSA

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF ODESSA, LINCOLN COUNTY, WASHINGTON, AS FOLLOWS, TO WIT:

**Section 1: Collection Rates**

Section 1 of Ordinance No. 643 is hereby rescinded in its entirety, and the following fees are hereby adopted:

Charges per month for collection Of containers placed at curb or alley line	Once a Week Pickup
Per month charge for a 65 gallon auto cart	\$ 25.40
Per month charge for a 95 gallon auto cart	\$ 32.30
Each extra (cans, boxes, bags, or tied bundles, Up to 32 gallon capacity)	\$ 7.30
Each extra loose yards (cans, boxes bags, or tied bundles)	\$ 28.40
Per month charge for a 1 cubic yard dumpster	\$ 64.00
Per month charge for a 2 cubic yard dumpster	\$117.50
Per month charge for a 3 cubic yard dumpster	\$171.00
Per month charge for a 4 cubic yard dumpster	\$224.15
Per month charge for a 6 cubic yard dumpster	\$341.75
Per month charge for an 8 cubic yard dumpster	\$448.10
Dumpster delivery service fee	\$ 29.50
Per week dumpster rental fee, with 1 week minimum rental	\$ 11.50

Additional weekly pickup charged as multiple of monthly rates listed above.

**Section 2: State Refuse Tax**

Residential and commercial rates include state required solid waste and refuse tax that the Town is obligated to collect and pay to the State of Washington.

**Section 3: Nonliability**

Nothing contained in this ordinance is intended to be, construed to create or form the basis for any liability on the part of the Town authority, or their respective officers, employees or agents, for any injury or damage resulting from the failure of any person to comply with the terms of this chapter, or by reason or in consequence of any omission in connection with the implantation or enforcement of this ordinance on the part of the Town and its officers, employees or agents.

**Section 4: Severability and Validity**

Should any section, paragraph, sentence clause or phrase of this ordinance, or its application to any person or circumstance, be declared unconstitutional or otherwise invalid for any reason, or should any portion of this ordinance be pre-empted by state or federal law or regulation, such decision or pre-emption shall not affect the validity of the remaining portions of this ordinance or its application to other persons or circumstances.

**Section 5:** Any and all ordinances and resolutions or parts thereof in conflict with this ordinance are hereby repealed.

**Section 6:** This ordinance shall be in full force and effect 45 days from and after its passage, approval and publication.
