

RESOLUTION 2009-11

A RESOLUTION FIXING THE WATER RATE SCHEDULE AND SUPPLEMENTAL CHARGES FOR THE TOWN OF ODESSA, LINCOLN COUNTY, WASHINGTON AND AMENDING RESOLUTION 2008-16 AND O.M.C. CHAPTER 13.04, SECTION 13.04.180

WHEREAS, Ordinance No. 574 allows for the Odessa Town Council action by resolution to fix the water rate schedule and supplemental charges; and

WHEREAS, the Odessa Town Council has determined that a decrease to the base water rate may be made for the upcoming budget; and

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE TOWN OF ODESSA, LINCOLN COUNTY, WASHINGTON that the following rates for water and supplemental charges be charged as follows:

Beginning December 31, 2009 the monthly water rate schedule and charges of the Town of Odessa, Washington, shall be as follows:

For the first 680 Cu. Ft. or any fraction thereof.....\$17.25
For each 100 Cu Ft. or any fraction thereof in excess of 680 Cu. Ft.....\$ .70

Rental for each water meter owned by the Town of Odessa shall be as follows:

3/4 inch meter.....\$1.00
1 inch meter.....\$1.25
1 1/2 inch meter.....\$1.75
2 inch meter.....\$2.00

Additional charges are as follows:

For each meter located outside the corporate limits of the
Town of Odessa- surcharge..... \$10.00
For each time that an individual requests that the property's water be
turned on or turned off, for other than repair.....\$25.00
Discontinuance of service notification delivery..... \$10.00
Discontinuance of service for violation. In addition to the delinquency
penalty set for in OMC 13.04.205, service charge for water turned on
or turned off.....\$50.00
Connection to the water system within corporate Town limits shall be
borne by the property owner, provided, that in no event shall the
fee and costs for the installation be less than.....\$1,000.00
Connection to the water system outside corporate Town limits shall be
borne by the property owner, ..... \$1,000.00
plus.....cost of labor and materials.

The charges herein above set forth are to be made for each calendar month or FRACTION thereof from and after December 31, 2009.

The water rates shall automatically increase by 5% each year beginning January 1, 2011, subject to Council's vote to not allow said increase or to change the percentage rate increase.

All other ordinances and resolutions or parts thereof in conflict with this Resolution are hereby repealed.
